Ensure Access to Affordable Housing and Health Services

Rent was unaffordable for 52.9% of renters.

15.8% did not have health insurance.

There are 843 residents for every mental health provider.



Address Structural Barriers to Equality

46.8% of residents are low-income (\$48,600 or less for a family of four).

The richest 5% of households have an average income 34 times greater than the poorest fifth and 7 times the typical household.
