## **Ensure Access to Affordable Housing and Health Services**

Rent was unaffordable for 55.7% of renters.

14.6% did not have health insurance.

There are 2,222 residents for every mental health provider.



### Address Structural Barriers to Equality

54.1% of residents are low-income (\$48,600 or less for a family of four).

The richest 5% of households have an average income 24 times greater than the poorest fifth and 6 times the typical household.
