COUNTY WAGE PROFILE: **Bladen County**

These County Profiles provide a look at how workers in North Carolina counties are faring in North Carolina's low-wage economy. Bladen County is a Tier 1 county and has a working-age population of 22,255.¹

POVERTY

26 percent of the county's residents (8,760) lived in poverty in 2012; the state poverty rate was 18 percent.³

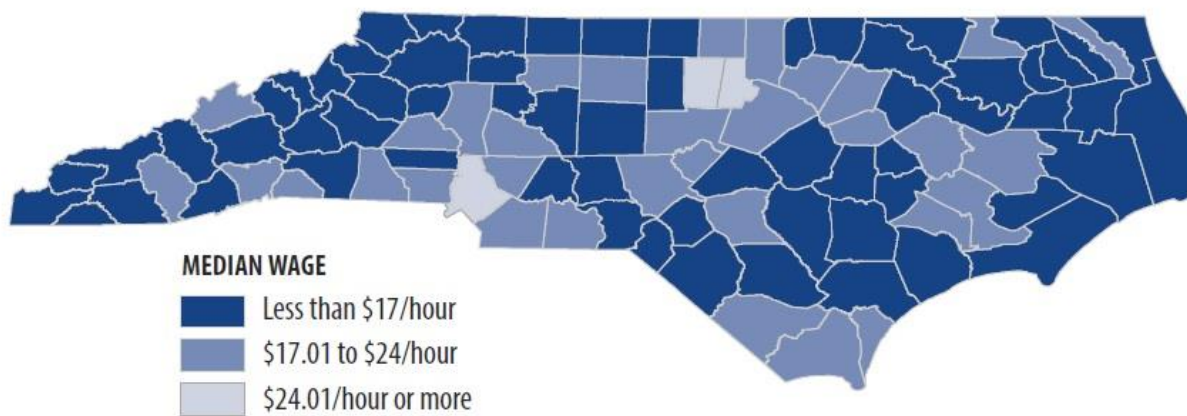
Poverty for people of color is significantly higher than for whites: 36 percent of African Americans and 65 percent of Hispanics live in poverty, while 14 percent of whites live in poverty.

54 percent of the county's residents were low-income on average from 2010 to 2012, meaning their incomes were less than twice the federal poverty level (\$46,100 for a family of four in 2012).⁴

13 percent of working-age people in the county live below the poverty line (\$23,500 for a family of four), while 20 percent are considered near-poor—they earn 125 percent of the poverty line.

WAGES & INCOME

The county's median hourly wage, the wage of the worker in the middle of the distribution of all workers in Bladen County, is \$12.85.

Median household income in the county was \$32,766, which equaled 73 percent of the statewide household income of \$45,195 in 2012.⁶

The richest 5% of the county's households had an average income that was almost 29 times greater than that of the poorest fifth of households and almost 7 times greater than that of the middle fifth of households on average from 2010 to 2012.⁷

WORK

The number of employed persons in the county declined by 12 persons from January 2013 to January 2014.

The percentage of working-age people with jobs—a better measure of the availability of work than the unemployment rate—is 60.4 percent in Bladen County, which is 7.3 points below the state average.

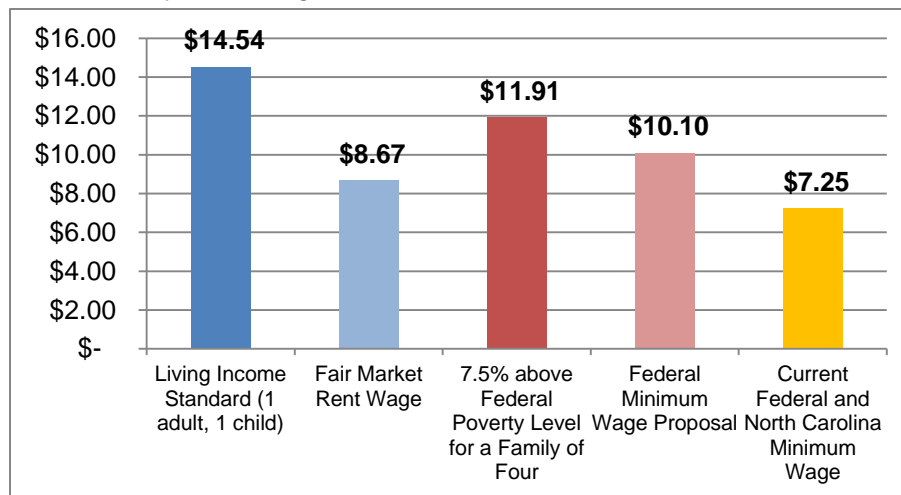
43 percent of occupations pay an average wage below the Living Income Standard for one adult, one child of \$14.54.

LIVING WAGE MEASURES

There are various measures that seek to capture what it takes to make ends meet for working families. The figure below demonstrates that many of the current measures being used fail to adequately provide a wage that allows a family to meet their basic needs in Bladen County as measured by the Living Income Standard.
