Ensure Access to Affordable Housing and Health Services

Rent was unaffordable for 42.2% of renters.

11.8% did not have health insurance.

There are 2,113 residents for every mental health provider.



Address Structural Barriers to Equality

36.7% of residents are low-income (\$49,200 or less for a family of four).

The richest 5% of households have an average income 22 times greater than the poorest fifth and 6 times the typical household.
