In the past year, the county's unemployment rate has gone from 4.8% to 4.3%.



## Ensure Access to Affordable Housing and Health Services

Rent was unaffordable for 46.3% of renters.

11.2% did not have health insurance.

There are 812 residents for every mental health provider.



### Address Structural Barriers to Equality

41.5% of residents are low-income (\$49,200 or less for a family of four).

The richest 5% of households have an average income 21 times greater than the poorest fifth and 5 times the typical household.
