Ensure Access to Affordable Housing and Health Services

Rent was unaffordable for 43.3% of renters.

14% did not have health insurance.

There are 1,988 residents for every mental health provider.



Address Structural Barriers to Equality

46.8% of residents are low-income (\$49,200 or less for a family of four).

The richest 5% of households have an average income 27 times greater than the poorest fifth and 7 times the typical household.
