## **Ensure Access to Affordable Housing and Health Services**

Rent was unaffordable for 60.5% of renters.

12.7% did not have health insurance.

There are 924 residents for every mental health provider.



# Address Structural Barriers to Equality

50.1% of residents are low-income (\$49,200 or less for a family of four).

The richest 5% of households have an average income 44 times greater than the poorest fifth and 6 times the typical household.
